Officer Wellness



Katy Malloy Support Lieutenant

Lieutenant Malloy has been with the Carmel Police Department for 24 years. She is a graduate of Purdue University and the IMPD Leadership Academy. She served as a dual-purpose handler with the Carmel Police Department K-9 Unit for 13 years and a Commander with the Event Response Group (ERG). She currently serves as the Support Lieutenant and the K-9 Unit Supervisor.

Mental Health Initiative

The Carmel Police Department prioritizes the mental well-being of officers by offering unlimited counseling sessions with vetted, culturally competent counselors. These sessions are fully funded by the department, ensuring that officers have access to the support they need to maintain their mental health and perform their duties effectively.

Police Officer Support Team (POST)

POST members shall consist of employees, trained in stress-related intervention, and mental health professionals oriented to the workings of a law enforcement agency. The goal of the Department in establishing the Police Officer Support Team is to assist employees in coping with psychological effects and emotions that they may experience after certain highly traumatic events, and to provide support and education about critical incident stress. POST members are not investigators involved in the administrative and/or criminal investigation of the critical incident.

Therapy Dog: Macy

The Carmel Police Department features an on-site therapy dog named Macy, who helps officers de-stress and unwind during their shifts. In addition to Macy, the department also has two mental health professionals available on-site, providing officers with immediate access to support whenever needed. This comprehensive approach ensures that officers have the resources to manage stress and maintain their mental well-being while serving the community.

Officer Wellness

Physical Incentive

Program

Officers are required to attend the Physical Assessment Tests (PAT) semi-annually, but participation is optional. The PAT is intended to help identify areas of physical limitation or deconditioning that could place the officer(s) at increased risk of injury while performing their duties and ensure officer readiness. Officers who score at least 5 points on the PAT or pass the endurance course giving their best effort will be eligible for a Health and Fitness Incentive.

Tactical Athlete Program

In 2020, a partnership with Forte Sports Medicine and Orthopedics, was established with their Tactical Athlete Program. The program provides the highest quality of care which includes screenings, patient education, individualized preventative programming, thorough on-site evaluation, rehabilitation services, and referrals to Forte's network of highly skilled subspecialist physicians. This program allows our officers the opportunity to take care of their injuries and ailments that allows them to do the job at a high level.



Chase Larrison
Physical Fitness Coordinator

Chase Larrison holds extensive experience as a CrossFit coach and is the founder of Black Dog Fitness LLC. With a focus on both strength and cardiovascular training, he has successfully guided athletes to compete in the CrossFit Games. Professional Staff

Professional staff refers to non-sworn employees who support the department's operations in various administrative, technical, and specialized roles, but do not have law enforcement authority. Professional Staff account for approximately 20% of Police Department employees and provide support for all divisions throughout the department.



Professional staff plays a crucial role in supporting the day-to-day operations of the department, ensuring everything runs smoothly behind the scenes. They manage essential tasks such as maintaining accurate records, processing reports, and handling administrative duties that allow officers to focus on law enforcement. Additionally, they are key in organizing and coordinating community events, outreach programs, and public relations efforts that help strengthen the relationship between the department and the community. Their contributions ensure that the department operates efficiently and effectively, creating a stronger, more connected community.



School Resource Unit



Adam Miller Lieutenant of SRU

The Carmel Police Department's School Resource Unit (SRU) provides school administrators and staff with law enforcement resources and expertise they need to maintain safety, order and discipline in the school environment. The SRU consists of a Lieutenant, two Sergeants, and 18 School Resource Officers (SROs). Every SRO is trained through the National Association of School Resource Officers (NASRO) utilizing the

concepts of teaching, informal counseling, and school protection (law enforcement). Each elementary and middle school have an SRO assigned. Four SROs are stationed at the high school.

The SRU's mission is to provide a safe environment for the students, staff, and families within the Carmel Clay Schools Community while building relationships, providing education, and mentoring students. The School Resource Unit conducts the Teen Academy, Youth Academy, and the Carmel Police Cadets.





Operations Division

The Carmel Police Department's Operations Division is the largest and most visible component of the department, responsible for ensuring community safety. Divided into six districts, uniformed officers are assigned to each district to handle calls for service, including crime reports, investigations, traffic enforcement, and community policing. Major Collins oversees the daily operations, ensuring the division runs smoothly.

Patrol officers maintain a constant presence within the community through routine patrols and respond to both emergency and non-emergency calls. They assist with business and residential welfare checks, provide security for public events, and enforce state laws and local ordinances. Officers also engage in crime prevention, detection, and deterrence, educating the public on crime trends and investigating incidents when they occur. Additionally, patrol officers investigate traffic accidents, ranging from property damage to serious injury or fatal accidents.

Through continuous training and commitment to public service, the Operations Division ensures the safety and well-being of the Carmel community.







Patrol Division

The Patrol Division is led by 1 Major and 4 Lieutenants, supported by a team of Sergeants and Patrol Officers. The division is organized into four shifts, along with a dedicated Traffic Division, ensuring comprehensive coverage and efficient response throughout the community.

Community Service Officers

Their contributions help ensure a well-rounded approach to community well-being and enhance the overall effectiveness of the department.

Traffic Unit

The Traffic Unit consists of officers dedicated to focusing on traffic enforcement within the community. When weather permits, these officers are often seen patrolling on motorcycles, actively working to improve road safety. Through a combination of education and strict enforcement of traffic laws, their goal is to reduce traffic violations and accidents. In addition to routine traffic enforcement, these officers are involved in traffic and enforcement planning, provide escorts, and assist with coordinating safety measures for all major community events. Their efforts play a key role in ensuring safer roadways for everyone.

Accident Investigation & Reconstruction

Unit

The Carmel Accident Investigation and Reconstruction Unit is made up of specially trained officers who respond to and thoroughly investigate all fatal accidents, as well as those resulting in serious bodily injury. These experts are dedicated to determining the causes of complex accidents, ensuring accurate and detailed investigations to support both public safety and legal proceedings.



Event Response Group

The mission of the Carmel Police Department ERG is to support the Carmel Police Department and any other law enforcement agency with a tactical response to civil disorder, to protect life and property, preserve civil rights and constitutionally protected freedoms, and maintain public order during pre-planned events, civil disturbances, public demonstrations and natural or man-made disasters.



Special Weapons & Tactics Team

The mission of the SWAT team is to support the Carmel Police Department and any other requesting law enforcement agency with a tactical response to critical incidents. These incidents may include barricaded persons, hostage situations, suicidal persons, assisting with warrant services and the apprehension of armed or potentially armed suspects. The team also assists with personal protection details, crowd control and other special assignments approved by the Chief of Police.



Drug Recognition Experts

Certified Drug Recognition Experts (DREs) play a critical role in identifying individuals under the influence of drugs by recognizing the physical and behavioral effects of substances on the human body. Their specialized expertise provides invaluable support not only to their fellow officers but also to neighboring agencies, enhancing overall efforts to keep our roads and communities safe.



Crisis Negotiation Team

The mission of the Crisis Negotiation Team is to resolve crisis situations with precision and professionalism, ensuring the safety of all individuals involved. Comprised of 11 dedicated department members, the team remains committed to ongoing training throughout the year, continuously refining their skills and staying up-to-date with the latest crisis intervention techniques. Their collaborative efforts with patrol operations and other units have led to numerous successful resolutions, ultimately contributing to the safety and well-being of our community.



K-9 Unit

The mission of the Carmel Police K-9 Unit is to support department personnel by utilizing specially trained police dogs for various purposes, including apprehending criminal suspects, detecting narcotics, and locating missing persons. The K-9 Unit serves as a valuable asset to law enforcement, and their deployment may be authorized during police operations when their involvement can enhance the success of specific objectives. K-9s and their handlers function as a highly trained team and undergo ongoing monthly training as well as annual certifications to maintain their skills and effectiveness.

Investigations Division

The Investigations Division consists of four units: Criminal Investigations, Special Investigations, Intelligence Unit and Crime Scene Investigations. Major Meyer is responsible for managing the daily operations and personnel of this division, including the Hamilton County/Boone County Drug Task Force.

Criminal Investigations Lieutenant

The Criminal Investigations Division is responsible for the investigation of both personal and property crimes that have occurred within the City of Carmel. In addition to investigating crimes that have already occurred, detectives regularly conduct surveillance details and other proactive activities which are designed to detect and deter criminal activity before it actually occurs. Detectives use collected evidence and

information obtained from their investigations to make criminal arrests and to assist with criminal prosecutions. Lieutenant John Foster reviews cases reported to officers, determines which ones will be assigned to detectives for additional investigation, and supervises the actual investigative process by CID personnel.

Personal & Property Crime Investigations

The Criminal Investigations Division is responsible for investigating a wide range of property crimes, including robbery, theft, fraud, burglary, and other serious offenses involving the loss of property to victims. These investigations often result in criminal arrests and the recovery of stolen property. In addition, the division handles a significant number of personal crimes, such as adult sexual assaults, elder abuse, death investigations, child sex crimes, and other violent offenses. Detectives collaborate closely with the Department of Child Services and Child Advocacy Centers to ensure thorough and compassionate investigations, particularly in sensitive cases involving violence against individuals.

Crime Scene Investigation/Property Room

Crime Scene Investigation/Property Room Crime Scene Investigators handle evidence recovery and crime scene preservation. The Property Room Clerk maintains found property, confiscated weapons, contraband, drugs, money and other items seized during police investigations. Carmel Police Department personnel rely heavily upon Crime Scene Investigators as they are responsible for gathering evidence that leads to numerous arrests due to DNA, fingerprints, and other evidentiary items they find and process. The Forensics Unit is comprised of Crime Scene Investigators and a Property Room Clerk.

Special Investigations Unit

The Special Investigations Unit is made up of two specialized components: the Hamilton/Boone County Drug Task Force and the Carmel Police Department's Intelligence Unit.

Hamilton/Boone County Drug Task Force

The Hamilton/Boone County Drug Task Force is a multi-agency, multi-jurisdictional team focused on conducting covert undercover drug investigations primarily within Hamilton and Boone Counties. In 2023, the task force marked its 33rd year of operation. Covering 825 square miles with a population of over 438,085 (2022 U.S. Census Bureau), the task force is a collaborative effort, with officers from various agencies working together in a shared office, pooling resources from each participating department. In 2024, the task force was comprised of the Fishers Police Department, Lebanon Police Department, Hamilton County Sheriff's Office, Boone County Sheriff's Office, Zionsville Police Department, Whitestown Police Department, Carmel Police Department, and the Prosecutor's Offices of both Hamilton and Boone Counties. Additionally, the task force regularly partners with local, state, and federal agencies throughout central Indiana to combat drug-related crimes and enhance public safety.

Mission Statement

The Hamilton/Boone County Drug Task Force is committed to the suppression of illegal drugs and narcotics. The Drug Task Force, through the combined efforts of local, state and federal agencies, will actively pursue those groups or individuals who manufacture, distribute, store or sell illegal drugs within the jurisdictional boundaries of Hamilton and Boone Counties. The Task Force is also committed to working with all other agencies outside of Hamilton and Boone Counties having an impact of illegal drug activity within Hamilton and Boone Counties. The Task Force is committed to protecting the safety, dignity, and quality of life of the citizens within our jurisdictional boundaries.

2024 Drug Removals

Hamilton County Metro ICAC Task Force

The Criminal Investigations Division has detectives assigned to the Hamilton County Metro Internet Crimes Against Children Task Force, a collaborative effort between the Carmel, Noblesville, and Fishers Police Departments, the Hamilton County Sheriff's Office, the Prosecutor's Office, and federal law enforcement agencies. This specialized task force is dedicated to addressing crimes against children facilitated through online communication, including child solicitation, exploitation, and the possession, dissemination, and production of child pornography. In addition to their investigative work, task force members actively engage in public outreach, conducting internet safety presentations for both adults and children to help raise awareness and prevent online crimes.

Real Time Information Center

Members of the CPD Intelligence Unit have partnered with members of the Hamilton County Sheriff's Department and Noblesville Police Department to form the Real Time Information Center (RTIC) utilizing a task force model. A central component of RTIC is the dedicated Drone First Responder (DFR) program for Carmel PD calls for service. Members of RTIC leverage digital assets throughout the county as force multipliers for officers/deputies in the field to conduct thorough investigations in the safest manner possible. A future goal for RTIC is to have representatives from all the agencies in the county join in.

Drone First Responder

The Drone First Responder (DFR) Program enhances the Carmel Police Department's existing patrol-led drone operations through the Carmel Police Air Support Unit. Operating under a waiver from the Federal Aviation Administration (FAA), these drones respond directly to calls for service alongside patrol officers, often reaching the scene before they do. This improved response efficiency allows the drones to provide valuable real-time information to the responding officers, enabling them to escalate or de-escalate their approach and, in some cases, resolve the situation before an officer even arrives. As a result, the DFR program increases safety for both officers and citizens, reduces response times, and streamlines the overall response to calls for service.


Carmel is only the second police department in Indiana to implement a DFR program and the first to integrate it with a Real-Time Information Center. Nationwide, the use of DFR is a rapidly growing trend, signifying a fundamental shift in how drones are employed for public safety. The Carmel Police Department is proud to be at the forefront of this innovative technology, reinforcing our commitment to leveraging cuttingedge tools to provide the highest level of service to our community.



Incidents







Occurred Incidents






