 - Should outline parameters for receiving support
 - Determination for how much support is given
- Other City departments may provide services, but they are nominal in comparison to those tracked
- Is anyone denied support and if so, how is that determination made?

Observations

- Vast majority of support for in-kind goes to Christkindlmarkt (85.5%). Vast majority of support for monetary goes to Center for Performing Arts (81.8%).
 - Agreement in place with Christkindlmarkt governing responsibilities
 - Several agreements in place with the Center for Performing Arts, but nothing memorialized regarding the annual yearly subsidy provided by the City
 - For consistency, require agreements for in-kind support to outline City responsibilities and partner responsibilities
- No Agreement in place for money spent with some entities receiving monetary support.
 - For consistency, include grant agreement going forward for these entities (except where sponsoring attendance driven events, etc.)
- No process for determining which entities receive money and/or how much is received
 - Is anyone denied?

 - Do not recommend this going forward
- Some receive in-kind or monetary support

Recommendations

- Template for uniform time tracking for partner and City events
- Create consistent process for determining which events receive in-kind support and how much support
- Require agreements for in-kind support to outline City and partner event responsibilities
- Consistent use of grant agreements for entities receiving monetary support from the City
- Create a rubric for determinations of which entities receive monetary support from the City and how much they receive
- OCC should not provide legal services to partner 501(c)(3)s, including creation of the 501(c)(3)
