# CARMEL COMMON COUNCIL MEETING MINUTES

MONDAY, OCTOBER 20, 2025 – 6:00 P.M. COUNCIL CHAMBERS/CITY HALL/ONE CIVIC SQUARE

## **MEETING CALLED TO ORDER**

Council President Adam Aasen; Council Members: Shannon Minnaar, Ryan Locke, Teresa Ayers, Matthew Snyder, Rich Taylor, Anthony Green and Deputy Clerk Jessica Komp were present. Councilor Anita Joshi arrived after the meeting started.

Council President Assen called the meeting to order at 6:00 p.m.

## **AGENDA APPROVAL**

The agenda was approved 8-0. (Councilor Joshi was not present at this time.)

## **INVOCATION**

Reverend Cara Spaccarelli of St. Christopher's Episcopal Church delivered the invocation.

## RECOGNITION OF CITY EMPLOYEES AND OUTSTANDING CITIZENS

Carmel Fire Chief Joel Thacker presented a "Stork Award" to Phillip Budde, Rodolfo Montes, Ben Krieg, Chris Kelly and Lt. Brad Allen of the Carmel Fire Department, Hamilton County 911 Operator, Nicole Chilemba, and Carmel Police Officer Thomas Szybowski. These individuals collectively delivered a baby when a couple had to stop their vehicle, unable to make it to the hospital in time. The beautiful baby girl was welcomed into the world around 2:00 a.m. on June 27<sup>th</sup>.

Carmel Police Chief Drake Sterling introduced five new Carmel Police Officers. Nathaniel Fordham, Jesus Gutierrez, Alex Garcia, Connor Jackson, and Elise Tarpley were all sworn-in by Mayor Sue Finkam.

## RECOGNITION OF PERSONS WHO WISH TO ADDRESS THE COUNCIL

Jack Feldman spoke to Council in support of Ordinance D-2795-25. Mr. Feldman believes it is important for city meetings to continue to take place in the evenings, as this is when citizens are most available to attend and participate. He believes that limiting city meetings to daytime hours would inhibit many working citizens and students from being actively engaged in these civic events.

Rachael Bailey spoke to Council in support of Ordinance D-2796-25. Rachael's son was hit by an e-bike last week while walking home from an after-school club, and has not been able to return to school yet, due to the injuries he sustained. As a marathoner, Rachael is on the Monon nearly every day, and has nearly been hit by an e-bike rider, who does not announce their passing, every time she goes out for a run or walk. She stated that these are usually middle schoolers, not wearing helmets. Ms. Bailey advocates for required licensing for

micromobility devices and mandatory driver education for anyone under the age of 16. She would also like to see lower speed zones for micromobility devices around schools, and education programs about this topic at the schools through the SRO's already in place at the schools.

Jordan Kohl spoke on behalf of Strong Towns, a local non-profit which focuses on safe streets. Mr. Kohl spoke in support of Ordinance D-2796-25, the micromobility ordinance, even though it is not yet perfect. As an everyday cyclist, Mr. Kohl recognizes the importance of safely operating micromobility devices in this community, for both the operators, and those they cross paths with. With the increasing popularity of these devices, Mr. Kohl believes we need more paths and places for everyone to walk, roll and ride without a car. He is hopeful that with a few more changes, this ordinance will help improve safety for everyone.

Matthew Broadnax, Vice President of the Carmel Fraternal Order of Police Lodge 185, spoke next. Officer Broadnax encouraged the Council to pass the budget. He thanked the Mayor for keeping her word and putting forth a budget that values public safety, and he thanked the Council for also valuing public safety.

Mike McKenzie, a resident of the Arts District, spoke last. His work as a pilot and aviation consultant has taken him all over the country, but no matter where he goes, people know about Carmel. Mr. McKenzie believes that Mayor Finkam has proposed a budget that faces the city's current challenges all while maintaining financial responsibility. He believes that the businesses that want to move here are looking at how the leaders of the city work together to achieve goals, such as the passing of this budget. He believes our reputation of having good governance gives us a competitive advantage that is worth protecting.

## **COUNCIL AND MAYORAL COMMENTS/OBSERVATIONS**

Councilor Snyder thanked Jack Feldman for his comments tonight, and for his civic involvement. Mr. Feldman is at almost every Land Use and Special Studies Committee meeting, asking important questions and furthering conversations. He also thanked Jordan Kohl for his comments tonight and commended the Strong Towns organization for accomplishing so many of their initiatives. He commented on the process of passing the budget, from the initial introduction of the budget, through the many meetings and conversations that shape its different revisions, until a final version is agreed upon by both the Mayor and the City Council. He stated that even though the debate may get heated, there is great respect amongst all of us, who are all working towards the common goal of serving this community.

Councilor Minnaar shared that the Diwali celebration at Carter Green that was originally scheduled for last Saturday has been rescheduled for this Thursday, October 23<sup>rd</sup>. She also thanked Jack Feldman for his comments, and her neighbor, Rachael Bailey, for coming to speak tonight. She thanked Councilor Snyder for sharing his insights on the budget approval process.

Council President Aasen thanked the Diwali celebration organizers for rescheduling the event, after it was cancelled due to inclement weather. He also explained that the budget was never planned to be approved prior to this second meeting in October, so we are not behind schedule.

## **CONSENT AGENDA**

Councilor Taylor moved to approve the consent agenda. Councilor Green seconded. There was no discussion. Council President Aasen called for the vote. The consent agenda was approved 8-0. (Councilor Joshi not present.)

## **COMMITTEE REPORTS**

Councilor Taylor stated that the Finance, Utilities and Rules Committee has not met since the last Council meeting.

Councilor Snyder shared that at the last Land Use and Special Studies meeting they made the final changes to the rental cap ordinance, and hopefully that will be approved tonight. He thanked everyone who came to discuss this ordinance and contribute to its contents. The committee also brought forth Ordinance D-2796-25, the micromobility ordinance. He knows it is not perfect, but it will get sent back to the Land Use committee to be discussed and revised. He stated that the committee will not be meeting this Wednesday, October 22<sup>nd</sup>, but will be meeting on Wednesday, November 5<sup>th</sup>.

## OTHER REPORTS – (at the first meeting of the month specified below):

Mark Dollase, Chair of the Carmel Historic Preservation Commission, gave their quarterly report. The CHPC met with St. Elizabeth Seton to discuss "The Blue School", which is the oldest standing historic school in the city. The Silas Moffitt House, which is now owned by Carmel Clay Parks and Recreation, is seeking the CHPC's advice on rehab matters and potential for rescue. They have also reached out to Ball State University's College of Architecture and Planning. The fall round of façade grant applications have been reviewed. On September 11<sup>th</sup>, the commission approved funding for all 8 of the eligible applicants. Total approved funding was approximately \$34,500.00. Research continues on the potential historic designation of the North Rangeline district.

Santosh Rajmane gave the Audit Committee's bi-annual report, sharing results for Fiscal Year End December 31, 2024. The auditor was the State Board of Accounts. The Exit Conference was on July 2, 2025. Attendees were the SBOA, Abby Parker (Coonrod & Company), The City of Carmel Finance Department and the Audit Committee members. The auditor concluded that the financial statements were presented fairly in all material aspects. The city's Annual Comprehensive Financial Report for fiscal year ended December 31, 2023 met the requirements to be awarded the GFOA's Certificate of Achievement for Excellence in Financial Reporting. The Office of Management and Budget (OMB) has updated the Uniform Guidance on Single Audits for fiscals years on or after October 1, 2024. Organizations receiving less than \$1,000,000.00 in federal funding will no longer be subject to a Single Audit. As of today, the City does not expect a Single Audit for Fiscal Year End December 31, 2025.

Council President Aasen then spoke about the agenda order, indicating that agenda items after the budget might not be discussed until much later this evening. Councilor Snyder made a motion to reorder the agenda, moving item 12.d. to the end of section 12, after 12.j. Councilor Green seconded. There was no discussion. Council President Aasen called for the vote. **Motion to Reorder the Agenda** approved, 9-0.

Council President Assen announced the third reading of **Ordinance D-2784-25**; An Ordinance of the Common Council of the City of Carmel, Indiana, Amending Chapter 4, Article 6 of the Carmel City Code; Sponsor(s): Councilor(s) Minnaar and Taylor. This item returns from the Land Use and Special Studies Committee. Councilor Snyder shared that the Land Use committee reworked some language in the ordinance at their last meeting. City Attorney Benjamine Legge shared the changes that were made, including a requirement for landlords to be in good standing with their HOA's, to not have criminal convictions related to the residential rental dwelling, penalties to letting a residential dwelling without registering for a permit, as well as the city's rights of revocation if it is determined that landlords are in violation of the ordinance's required conditions. In turn, landlords may make appeals to the Board of Public Works and Safety. Council President Aasen asked if this ordinance will apply to condos, and Mr. Legge replied that it is not our recommendation at this time. Councilor Taylor made a motion to amend the ordinance to reflect these changes. Councilor Green seconded. There was no discussion. Council President Aasen called for the vote. Motion to Amend approved, 9-0. Councilor Taylor made a motion to approve the ordinance as amended. Councilor Green seconded. There was no discussion. Council President Aasen called for the vote.

Council President Assen announced the second reading of Ordinance D-2792-25; An Ordinance of the Common Council of the City of Carmel, Indiana, Designating the Klingensmith-Pettiner Farmstead Historic District Located at 14420 Cherry Tree Road; Sponsor: Councilor Worrell. Mark Dollase of the CHPC shared information about the history of this property. Rosemary Pettiner, the owner of this property, also spoke in support of receiving this designation. Councilor Snyder asked about any future plans that may include putting a sidewalk or path near the road and Mr. Dollase answered that this type of scenario is covered in the preservation plan. Councilors Worrell and Minnaar both thanked Ms. Pettiner for taking such great care of this property. Councilor Worrell made a motion to approve the ordinance. Councilor Snyder seconded. There was no discussion. Council President Aasen called for the vote. Ordinance D-2792-25 approved, 9-0.

Council President Assen announced the second reading of Ordinance D-2793-25; An Ordinance of the Common Council of the City of Carmel, Indiana, Designating the Wilkinson-Hull House Historic District located at 2724 East Smoky Row; Sponsor: Councilor Worrell. Mark Dollase shared information about the history of this property, which has been under interim protection for several years. Mr. Dollase introduced the couple that owns this property and is working to restore it, Matt and Erin Uber. Mr. and Mrs. Uber both spoke in support of receiving this designation. Councilor Snyder commended them for working to restore this property, which was the last oil-fuelled home at the time that the Keystone & Smoky Row roundabout was being constructed. He also shared some anecdotes about Hank Hull, including the fact that his family donated all the land that the Carmel High School football stadium and parking lot sit on. Mayor Finkam also thanked the Uber family for restoring this important piece of Carmel's history. Councilor Worrell made a motion to approve the ordinance. Councilor Snyder seconded. There was no discussion. Council President Aasen called for the vote. **Ordinance D-2793-25** approved, 9-0.

Council President Aasen announced the second reading of <u>Ordinance D-2788-25</u>; An Ordinance of the Common Council of the City of Carmel, Indiana, Fixing Salaries of Appointed Officers and Employees of the Carmel City Court for the Year 2026; Sponsor: Councilor Taylor. Councilor moved to introduce the item into business. Councilor Minnaar seconded. City of Carmel Judge Brian Poindexter spoke in support of the Court's 2026 budget. Councilor Green moved to approve the ordinance. Councilor Snyder seconded. There was no discussion. Council President Aasen called for the vote. <u>Ordinance D-2788-25</u> approved, 9-0.

Council President Assen announced the second reading of Ordinance D-2790-25; An Ordinance of the Common Council of the City of Carmel, Indiana, Fixing Salaries of Appointed Officers and Employees of the City of Carmel, Indiana, for the Year 2026; Sponsor: Councilor Taylor. Zac Jackson explained that this ordinance uses the cleaned up titles that were worked on last year, but it does not change the existing Step and Grade compensation system. There was discussion amongst Councilors Aasen, Snyder and Worrell over two positions being kept in the ordinance, even though those positions are to remain vacant for at least a year or two, if not longer. Councilor Worrell made a motion to amend the ordinance to remove the Chief Infrastructure Officer and Executive Director of Economic Development positions from the ordinance. Councilor Locke seconded. There was no discussion. **Motion to Amend** the ordinance approved 7-0. (Councilors Taylor and Green opposed.) Councilor Taylor explained his opposition to the removal of the Chief Infrastructure Officer position, as he believes this role is integral to long-term capital asset management and replacement throughout the city. He stated that he is fine with the removal of the Economic Development Director position, as he already views the Mayor as the head of Economic Development for the city. Councilor Locke then moved to amend the amended ordinance by incorporating the changes proposed in Version A. These changes included updated numbers for biweekly pay of sworn, moving the Deputy CFO/Controller position back to Grade 21, including reorganization titles for Streets and Utilities, reinserting the "Transportation Development Coordinator", and removing a proposed new title "Equipment & Systems Coordinator." Councilor Green seconded the motion. There was no discussion. Council President Aasen called for the vote. Motion to Amend the Amended Ordinance approved, 9-0. Councilors Snyder and Minnaar then spoke of the importance of the Urban Forester position, as they are concerned that reductions made within this department will result in services not being provided. Councilor Snyder also spoke of his belief that the non-sworn in CPD and CFD, and those in the Street Department, should receive a pay increase beyond just the 3% COLA. He hopes that any surplus would be considered for this purpose. Councilor Locke expressed concern that the same methodology might not have been used to evaluate those roles outside of City Hall, as those inside of it. Mayor Finkam assured him that our Human Resources department took great care to ensure the salary study was conducted fairly. Councilor Taylor moved to approve Ordinance D-2790-25. Councilor Green seconded. There was no discussion. Council

Council President Aasen announced the second reading of **Ordinance D-2791-25**; An Ordinance of the Common Council of the City of Carmel, Indiana, Fixing Salaries of Elected Officials of the City of Carmel, Indiana, for the Year 2026; Sponsor: Councilor Taylor. Councilor Snyder moved to approve the ordinance. Councilor Taylor seconded. Councilor Locke stated that he is advocating for a 3% COLA for the Judge and the Clerk, as this is what we had agreed to last year. There was discussion as to whether no one should receive the COLA, or if everyone should receive it. Council President Aasen stated that if he receives it, he will donate it to Prime Life Enrichment. Mayor Finkam stated that the Judge and the Clerk did not receive the COLA because that is how they submitted their budgets. If the Council wishes to ensure they have the option to accept the COLA, this ordinance can be changed from "bi-annual salary" to "maximum bi-annual salary" and increasing the Judge and Clerk's amounts by 3%. This option was discussed, with concern expressed that this would amount to nothing, since the funding for these COLA's is not in the budget. Councilor Snyder withdrew his motion, but made a new motion to amend this ordinance to state a maximum bi-annual salary for elected officials increased by 3% for all. Councilor Joshi seconded the motion. She also stated that it is the Council's desire to align with the employees. Zac Jackson shared what those new amounts would be. There was no further discussion. Council President Aasen called for the vote. **Motion to Amend**

Council President Aasen announced the second reading of <u>Resolution CC-10-06-25-02</u>; A Resolution of the Common Council of the City of Carmel, Indiana, To Limit the Rate for Taxes Payable in 2026 and Authorize Necessary Temporary Borrowing Among City Funds; Sponsor(s): Councilor(s) Snyder, Taylor and Aasen. Councilor Taylor asked Zac Jackson if he is correct in that if there is a delta, this resolution caps our tax rate at our current tax rate. Mr. Jackson confirmed that Councilor Taylor is correct. Councilor Snyder moved to approve this resolution. Councilor Green seconded. There was no discussion. Council President Aasen called for the vote. <u>Resolution CC-10-06-25-02</u> approved, 9-0.

Council President Aasen announced the second reading of Ordinance D-2785-25; An Ordinance of the Common Council of the City of Carmel, Indiana, Establishing Appropriations for the 2026 Budget; Sponsor(s): Councilor(s) Snyder, Taylor and Aasen. Mayor Finkam stated that what is being presented is a compromised proposal, based on a lot of things that they've heard from the dais. It won't be perfect for anyone, but she believes it moves the ball forward and hopes that we can get this budget passed tonight. Zac Jackson highlighted the specific changes that have been made since the initial proposed budget. These changes included reducing CFD lateral recruits from 25 to 23 (saving \$300K), reducing the Law department's "Legal Fees" by \$125K, moving the remaining Economic Development appropriations (\$80K) to CRC, Moving IT's Flock camera contracts (\$225K) to Police, Increasing Arts Grants by \$110K (equal to 2025 spending), Increasing Police department budget by \$50K for City Hall after-hours security, and increasing landscaping contracts (\$115K) and concrete (\$100K) in the Streets/City Property Maintenance budget. These changes would increase the surplus by \$50K.

Councilor Green thanked Mr. Jackson, Mayor Finkam, and all of the staff for the work they've put into making these budget changes throughout this entire process. Councilor Snyder asked about the surplus for this year, and Mr. Jackson clarified that it will likely come in around \$1.5 million. It may be more than that, but it will likely not exceed \$2 million. This number would have been higher, but a law change in how the food and beverage tax can be used meant we had to back \$3.8 million out of the original forecasted surplus. Council President Aasen asked about funding for Prime Life Enrichment. Mayor Finkam answered that we have been working with a local non-profit to help fund PLF for that gap, and possibly more. If this funding does not come through, then the Mayor will work with the Council to come up with the \$50K from the city's budget next year. She also stated that we will have one Urban Forester on staff in the Street Department, and we will have a contract for \$50K for landscaping plan review in the DOCS budget. Councilors Minnaar and Worrell both stressed the importance of the Urban Forester's role, and the Mayor confirmed that the one Urban Forester that is staying on staff will be able to handle all of the responsibilities of the role. Councilor Worrell asked about reducing the \$80K that's being moved from Economic Development to CRC down to \$70K, thus eliminating the \$10K allotted for travel expenses. Mayor Finkam stated that would be fine. Council President Assen asked about the reduction of legal fees by \$125K. The Mayor stated that this was a compromise. Some Councilors have expressed concern about not being able to tell how the legal fees are being spent, but this is an executive privilege that the Mayor has. Redacted invoices are used so as not to share legal strategies. Council President Aasen asked why invoices pertaining to the Affiliate Review Committee would be redacted, since Councilor Locke was the Chair of that committee. Samantha Karn, Corporation Counsel, responded that the executive presented the information for that committee, and the executive holds the privilege to those invoices. She would not recommend the Mayor waive that privilege, nor would she recommend that the Council waive its privilege by sharing unredacted legal invoices, as there is strategy in those documents. Ted Nolting of Kroger, Gardis & Regas, the City Council's attorney, also stated that even when the Executive and the Legislative branches have aligned interests through a joint venture, the result of those might not necessarily be the same in terms of each branch's goals. Each branch wants what is said to their attorney protected, and each has a right to their privileged communication with

their counsel. Councilors Snyder and Joshi asked for more clarification on how the \$475K figure was reached for next year's legal fees, when we've only spent \$261K so far this year. Ms. Karn replied that we have actually spent more than that so far this year, but legal fees are billed in arrears, so we don't yet know what the incoming invoices will be. She stated that \$475K is a reasonable number that we can work with. We have encumbered monies that we've also used this year, but those won't last forever. Councilor Locke shared why this issue of privilege (not sharing the details of the legal invoices) is an issue for him. As the appropriators of the budget, the Council is unable to see where the taxpayers' dollars are being spent. He suggested that we continue to discuss this issue so we can come to an understanding of how these dollars are being spent, waiting to pass this budget until the November 3<sup>rd</sup> Council meeting. Councilor Taylor moved to work off the amended version of the budget that Zac presented tonight. Councilor Green seconded. There was no discussion. Council President Aasen called for the vote. Motion to Amend the budget into the new version approved, 9-0.

Councilor Worrell then made a motion to reduce the \$80K moved from economic development to CRC to \$70K. Councilor Snyder seconded. There was no discussion. Council President Aasen called for the vote. **Motion to Amend** budget by removing \$10K approved, 9-0.

Councilor Locke made a motion to zero out the law department's legal fees line item, so that a process can be established for more transparency in how those dollars are being spent going forward. Councilor Minnaar seconded. Councilors Worrell and Joshi asked questions about why this would go all the way to zero. Councilor Locke replied that we can then go forward with a new process, and if we get to an agreement, he would even sponsor an ordinance to reappropriate funds to this line item at a future date. Councilor Green expressed concern that this amendment is being used to put pressure on the Mayor to waive her executive privilege. Zac Jackson reminded Council that the lead time to appropriate funds can be a month, due to public noticing requirements. Councilor Taylor stated that he thinks it would be foolish to leave the city without legal funds if they are needed quickly. Mayor Finkam stated that this is a separation of powers issue. The executive oversees Corporation Counsel. Corporation Counsel selects outside counsel. City Council approves claims. It is not City Council's role to approve what work goes out to an outside firm. Council President Aasen then called for the vote. Motion to Amend budget by reducing legal fees to zero failed, 2-1-6. (Councilors Locke and Minnaar approved, Councilor Snyder abstained, Councilors Aasen, Taylor, Worrell, Green, Joshi and Ayers opposed.)

Councilor Snyder made a motion to amend the legal fees line item to \$350K. Councilor Taylor seconded. There was no discussion. Council President Aasen called for the vote. **Motion to Amend** budget by changing these legal fees to \$350K approved, 7-1-1. (Councilor Locke abstained, Councilor Joshi opposed.)

Councilor Snyder asked about lobbying fees. Mayor Finkam replied that we are moving from a DC firm to local firm Barnes & Thornburg. Having a federal lobbyist who lives in Carmel means we're working with someone who has Carmel on their mind every day. This will also be at a lower expense than the DC firm, so it is a double win. Councilors Snyder and Worrell also asked about staffing in the MAC department. The Mayor responded that there will be eight doing marketing and events, four doing communications, and four going to other departments. Councilor Snyder asked about the \$30K of commissions support in the MAC budget. Mayor Finkam replied that this goes to three commissions – Veterans, Seniors, and the Advisory Commission on Disability. Councilor Snyder asked if that number could be raised to \$45K, which is still down from this year's amount of \$60K, and Mayor Finkam agreed to this. Councilor Snyder made a motion to change this line item in the MAC budget from \$30K to \$45K. Councilor Taylor seconded. There was no discussion. Council President Aasen called for the vote. Motion to Amend commission support to \$45K approved, 9-0.

Councilor Green moved to approve the budget as amended. Councilor Taylor seconded. Zac Jackson recapped the amendments that were made beyond those included in the updated version of the budget. This

included the removal of \$10K of travel funds from CRC, reducing legal fees to \$350K, and increasing commission support to \$45K. Council President Aasen thanked Mayor Finkam for her willingness to work together with the Council on this budget, and especially for the commitment to support Prime Life Enrichment and the Arts Grants. There was no further discussion. Council President Aasen called for the vote. **Ordinance D-2785-25** approved as amended, 9-0. Mayor Finkam thanked the Council for all their diligent work over these last several weeks, and for their commitment to do right by the people of Carmel.

## **PUBLIC HEARINGS**

There were none.

## **NEW BUSINESS**

Council President Aasen announced the first reading of <u>Ordinance D-2794-25</u>; An Ordinance of the Common Council of the City of Carmel, Indiana, Fixing Salaries of Appointed Officers and Employees of the City of Carmel, Indiana, for the Year 2025; Sponsor(s): Councilor(s) Worrell, Aasen and Taylor. Councilor Worrell moved to introduce the item into business. Councilor Green seconded. Councilor Worrell presented the item to Council. Zac Jackson stated that this ordinance replaces the ordinance that failed at the last Council meeting, which used the recently performed salary study to update titles and pay ranges. This new ordinance will only update the titles needed to increase the pay of eight individuals that were determined to be deserving of a pay increase. These pay changes would be retroactive back to July 1<sup>st</sup>. Councilor Worell thanked the HR department for doing the work to get these eight employees to their deserved compensation level. He then moved to suspend the rules and act on this tonight. Councilor Green seconded. There was no further discussion. Council President Aasen called for the vote. <u>Motion to Suspend the Rules</u> approved, 9-0. Council President Aasen called for the vote. <u>Ordinance D-2794-25</u> approved, 9-0.

Council President Aasen announced the first reading of **Ordinance D-2795-25**; An Ordinance of the Common Council of the City of Carmel, Indiana, Establishing Public Areas of City Hall; Sponsor: Councilor Snyder. Councilor Snyder moved to introduce the item into business. Councilor Green seconded. Councilor Snyder presented the item to Council. He stated that this ordinance is in response to a concern that more public meetings will start taking place during daytime hours, when most working citizens would not be available to attend. Councilor Snyder wants to ensure that City Hall remains available for City Business during all reasonable meeting hours. Ted Nolting of Kroger, Gardis & Regas then spoke to Council. He stated that the purpose of this ordinance is to ensure that the public access areas of City Hall are open when public business or civic events are taking place. This does not mean that meetings will be required to happen during evening hours, either. It just means that the option for each body to choose when to hold their meetings will remain. There was discussion on whether public meetings can take place in the Caucus Room, and it was stated that meetings can take place there, as long as the room doesn't get over-crowded. Also, with the addition of after-hours security funding, this will improve safety at evening meetings. This ordinance was sent to the Land Use and Special Studies Committee for further discussion.

Council President Aasen announced the first reading of **Ordinance D-2796-25**; An Ordinance of the Common Council of the City of Carmel, Indiana, Amending Carmel City Code Chapter 3, Article 2, Section 3-58, Chapter 6, Article 4, Section 6-63, Chapter 8, Article 4, Sections 8-40 and 8-41, Chapter 8, Article 5, Section 8-46, and Adding Chapter 8, Article 4, Section 8-44; Sponsor(s): Councilor(s) Snyder, Ayers, Joshi and Minnaar. Councilor Minnaar moved to introduce the item into business. Councilor Green seconded. Councilor Minnaar presented the item to Council. Councilor Snyder stated that now we have this document, the Land Use committee will be taking another pass at fine-tuning it. He stated that the committee will be meeting on Wednesday, November 5<sup>th</sup>, at 5:30 p.m., at a location to be determined, so look for the public notice coming soon. Councilor Taylor asked the committee to please address a helmet requirement for

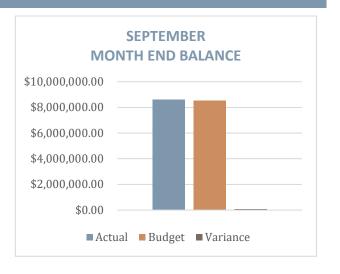

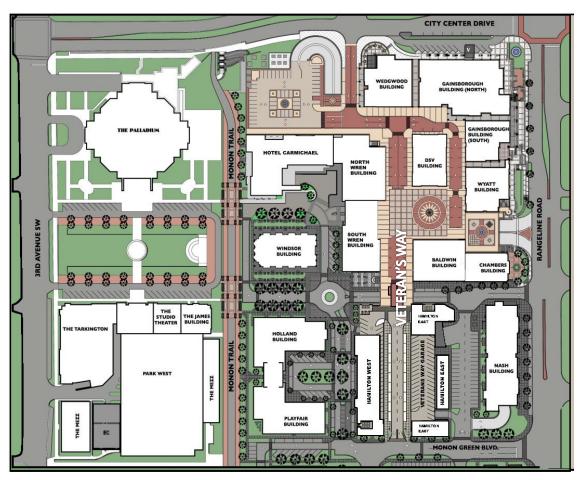


Figure 1 City Center Master Plan, provided by Pedcor City Center Development Company

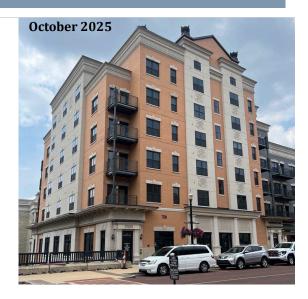

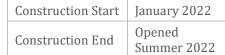

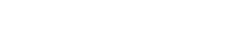

## AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF CARMEL, INDIANA, AMENDING CARMEL CITY CODE CHAPTER 3, ARTICLE 2, SECTION 3-58, CHAPTER 6, ARTICLE 4, SECTION 6-63, CHAPTER 8, ARTICLE 4, SECTIONS 8-40 AND 8-41, CHAPTER 8, ARTICLE 5, SECTION 8-46, AND ADDING CHAPTER 8, ARTICLE 4, SECTION 8-44

Synopsis: Ordinance establishing regulations of the use of micromobility devices within the City of Carmel

WHEREAS, the City of Carmel (the "City") desires to provide safe, efficient, and sustainable transportation options for its residents, visitors, and businesses; and

WHEREAS, the use of micromobility devices, such as electric scooters, electric bicycles and others, has increased substantially, offering a convenient, environmentally conscious, and affordable mode of transportation for short-distance trips; and

WHEREAS, it is essential to establish clear regulations governing the operation of micromobility devices to ensure the safety of riders, pedestrians, and other users of City's multiuse path, sidewalk, trail, and road networks, and to promote sustainable transportation options while managing potential conflicts, minimizing risks to riders, pedestrians, and congestion, and maintaining the high quality of life enjoyed by Carmel residents: and

WHEREAS, these regulations are intended to complement and not supersede existing state and federal laws pertaining to the operation of motor vehicles and other transportation devices.

NOW, THEREFORE, BE IT ORDAINED, by the Common Council of the City of Carmel, Indiana, as follows:

Section 1. The foregoing Recitals are fully incorporated herein by this reference.

Section 2. Chapter 8 Article 4 Section 8-44 of Carmel City Code is hereby added and shall read as follows:

"§ 8-44 Micromobility Devices.

(a) Definitions. For the purpose of this section, the following definitions shall apply:

Micromobility Device. Any open-air device designed for personal transportation, propelled wholly or in part by a mechanical or electrical motor, regardless of whether it also incorporates human power, and typically operating at lower speeds than traditional motor vehicles like cars or motorcycles. The term does not include golf carts, electric mopeds capable of reaching speeds exceeding 20 miles per hour, and electric motorcycles.

Electric-Scooter. A device weighing less than one hundred (100) pounds that is equipped with two or three wheels, handlebars, and an electric motor, and which is solely powered by the rider or by an electric motor capable of propelling the device without additional propulsion supplied by the rider, at a maximum speed on a paved level surface of no more than twenty miles per hour, or both.

**E-Bike.** A bicycle with an electric or mechanical motor that assists pedaling, classified into Class 1 (pedal-assist up to 20 mph), Class 2 (throttle-assisted up to 20 mph), and Class 3 (pedal-assist up to 28 mph).

**Greenway Trails.** The following multi-use trails within the City of Carmel: the Monon Greenway, the Hagan-Burke Trail, the Greyhound Trail, and the White River Greenway.

Multi-Use Trail. A paved or unpaved path designated for use by pedestrians, bicyclists, and other micromobility devices.

**Sidewalk.** The portion of a street between the curb line and the adjacent property line intended only for pedestrian use that is less than 6' wide typically made of concrete.

**Street.** The entire width between boundary lines of every way publicly maintained when any part thereof is open to the use of the public for purposes of vehicular travel.

Park. Any land owned or managed by the Carmel Clay Parks and Recreation Department.

## (b) General Regulations.

- i. Permitted and Restricted Locations. Micromobility Devices may be operated in the following areas:
  - 1. Except for limited exceptions for device-specific regulations as set forth in this Section, any Streets within the City of Carmel having a posted speed limit of thirty-five (35) miles per hour or less. Operators must adhere to the same traffic laws and regulations as bicyclists. All Micromobility Devices operated on a Street shall be operated on the right half of the Street, except under any of the following situations:
    - A. When using a facility designed or designated through signage and/or pavement markings for the use of bicycle traffic.
    - B. When riding alongside or overtaking and passing another micromobility device proceeding in the same direction.
    - C. When preparing for a left turn at an intersection or into a private road or driveway.
    - D. When necessary to avoid conditions that make it unsafe to continue along the right half of the Street.
    - E. When traveling straight through an intersection that has a dedicated right turn only lane.
  - 2. Designated bicycle lanes and Multi-Use Trails, including, but not limited to, the Monon Greenway, unless otherwise restricted by signage or this section.
  - 3. Parks and other recreational areas, subject to regulations and closures established by the Carmel Clay Parks and Recreation Department.
  - 4. Micromobility Devices may be operated upon the public Sidewalks in a careful and prudent manner except where signs are erected to prohibit riding on the Sidewalk where users shall walk their micromobility device.
- ii. Speed Limits:
  - 1. The maximum speed limit for Micromobility Devices on Streets shall be twenty (20) miles per hour unless otherwise posted.
  - 2. On Multi-Use Trails, including the Monon Greenway, the maximum speed limit shall be fifteen (15) miles per hour, unless otherwise posted.
  - 3. When approaching crosswalks, intersections, or areas with high pedestrian traffic, operators must reduce their speed to a safe and reasonable level.

  - A. Shall not exceed a weight of 100 pounds;
  - B. Shall be parked in designated parking areas or, where none exist, in a manner that does not obstruct Sidewalks, building entrances, or access for persons with disabilities;
  - C. Shall not be parked against windows, on benches, or in a manner that damages public or private property; and
  - D. Shall not use locking devices or attachments that damage public or private property.

- 3) An electric personal assistance mobility device that constitutes a self-balancing, two-wheeled device designed to transport one person with an electric propulsion system with an average power of 750 watts or one horsepower and that has a maximum speed of less than 20 miles per hour when operated on a paved level surface powered solely by said propulsion system and is operated by a person weighing 170 pounds;
- 4) A City or Carmel-Clay Parks and Recreation owned or leased snow plow, snow blower, sweeper, lawn mower, maintenance vehicle or repair vehicle;
- 5) A City or Carmel-Clay Parks and Recreation owned or leased public safety vehicle;
- 6) An Authorized Emergency Vehicle, as that term is defined in City Code § 8-1;
- 7) A lawn mower, sweeper, or snow removal machine weighing no more than 2,200 pounds; and
- 8) Any vehicle so designated in writing by the City of Carmel Board of Public Works and Safety. **Roadway.** All roads, streets, highways, alleys, courts, squares, or other public ways in the City that are dedicated and open to public use for Motor Vehicle traffic.
- (b) *Drivers to Exercise Due Care*. The driver of any Motor Vehicle operating on any roadway located within the City's corporate limits shall exercise due care to avoid colliding with any person then operating a Bicycle or Micromobility Device upon such Roadway, and shall, as necessary, give warning by the sounding of a horn and by exercising such other precautions as are necessary to avoid a Motor Vehicle and Bicycle or Micromobility Device collision.
- (c) Turning Right in Front of a Bicycle. When a Motor Vehicle and a Bicycle or Micromobility Device are traveling in the same direction on or along any Roadway located within the City's corporate limits, the operator of the Motor Vehicle overtaking such Bicycle or Micromobility Device shall not turn to the right in front of the Bicycle or Micromobility Device until the Motor Vehicle is safely ahead and clear of the Bicycle or Micromobility Device so as not to strike it or impede the Bicycle's or Micromobility Device's forward progress.
- (d) *Turning Left in Front of a Bicycle*. The driver of a Motor Vehicle operating within the City's corporate limits shall, when entering an intersection with the intention of turning left therein, yield the right-of-way to a Bicycle or Micromobility Device then approaching the intersection from the opposite direction whenever a failure to do so would cause the approaching Bicycle or Micromobility Device to strike the Motor Vehicle or to engage in evasive actions that impede the Bicycle's or Micromobility Device's forward progress in order to avoid such a collision.

    - (1) No person operating a Bicycle or Micromobility Device on a Roadway or Bicycle Lane shall ride other than upon the permanent and regular seat attached thereto, carry any other person upon such Bicycle otherwise than upon a firmly attached and regular seat thereon.
    - (2) No person operating a Bicycle or Micromobility Device on a Roadway or Bicycle Lane shall carry any package, bundle, or article which prevents him or her from keeping both hands upon the handlebars.
    - (3) No person shall operate a Bicycle or Micromobility Device on a Roadway or Bicycle Lane from one-half hour after sunset until one-half hour before sunrise unless the Bicycle is equipped with a light on the front of the Bicycle exhibiting a white light visible from at least 500 feet to the front and a light or reflector on the rear visible from at least 500 feet to the rear.
    - (4) The operator of any Bicycle or Micromobility Device on a Roadway or Bicycle Lane shall signal his/her intent to turn, stop, or decrease speed by giving the hand/arm signals required by state law.
    - (5) The operator of any Bicycle or Micromobility Device on a Roadway or Bicycle Lane shall obey all posted stop and/or yield signs."

Section 6. Chapter 8 Article 4 Section 8-41 of Carmel City Code is hereby amended and shall read as follows:

"§ 8-41 Operation of Motor Vehicles in Roadways with Bicycle Lanes.

(a) Definitions.

 **Bicycle.** Any vehicle that is foot-propelled and propelled by human power only vehicle, irrespective of the number of wheels in contact with the ground.

**Bicycle Lane.** That portion of a Roadway or Roadway shoulder that has been distinguished from the portion of the Roadway that is to be used by Motor Vehicle traffic by a painted stripe, a curb, or another bicyclist traffic control marking or device. In any action brought to enforce the provisions of this section, the City shall have the burden of proof that a Bicycle Lane has been clearly demarcated and properly signed.

Micromobility Device. A Micromobility Device has the meaning set forth and as defined under § 8-44. Motor Vehicle. Any vehicle that is propelled in whole or in part by a motor or any mechanical or artificial means, or is being pushed or towed by the same, except:

- 1) A Bicycle or Micromobility Device;
- 2) A manual or power wheelchair;
- 3) An electric personal assistance mobility device that constitutes a self-balancing, two-wheeled device designed to transport one person with an electric propulsion system with an average power of 750 watts or one horsepower and that has a maximum speed of less than 20 miles per hour when operated on a paved level surface powered solely by said propulsion system and is operated by a person weighing 170 pounds;

- 4) A City or Carmel-Clay Parks and Recreation owned or leased snow plow, snow blower, sweeper, lawn mower, maintenance vehicle or repair vehicle;
- 5) A City or Carmel-Clay Parks and Recreation owned or leased public safety vehicle;
- 6) An Authorized Emergency Vehicle, as that term is defined in City Code § 8-1;
- 7) A lawn mower, sweeper, or snow removal machine weighing no more than 2,200 pounds; and
- 8) Any vehicle so designated in writing by the City of Carmel Board of Public Works and Safety. **Roadway.** All roads, streets, highways, alleys, courts, squares, or other public ways in the City that are dedicated and open to public use for Motor Vehicle traffic.
- (b) *Operating on Roadways that Contain a Bicycle Lane*. The driver of any Motor Vehicle then operating within the City's corporate limits shall, when traveling on a Roadway that contains a designated Bicycle Lane, yield the right-of-way to all persons then operating Bicycles or Micromobility Device on and within said Bicycle Lane.
- (c) Turning on Roadways with Bicycle Lanes. The driver of any Motor Vehicle operating within the City's corporate limits shall, when traveling on a Roadway that contains a designated Bicycle Lane, enter the Bicycle Lane to make a right turn only after yielding to all persons then operating a Bicycle or Micromobility Device on and within said Bicycle Lane and only when doing so will not cause any Bicyclist or Micromobility Device operator to collide with the Motor Vehicle or to take evasive actions that impede the Bicycle's or Micromobility Device's forward progress in order to avoid such a collision.
- (d) *Driving on Bicycle Lanes*. No driver of any Motor Vehicle operating within the City's corporate limits shall drive and or park said Motor Vehicle in, on, or upon any designated Bicycle Lane or otherwise impede any Bicycle or Micromobility Device then operating on and within said Bicycle Lane except when safely entering or exiting a legal parking space and then only after yielding to all persons then operating a Bicycle or Micromobility Device on or within said Bicycle Lane and when doing so will not cause any Bicyclist or Micromobility Device operator to collide with the Motor Vehicle or to take evasive actions that impede its forward progress in order to avoid such a collision."
- Section 7. Chapter 8 Article 5 Section 8-46 of Carmel City Code is hereby amended and shall read as follows:
  - "§ 8-46 General Parking Restrictions.
  - (e) Bicycle and Micromobility Device Parking.
    - (1) No person shall park any bicycle or Micromobility Device (for purposes of this Section, a Micromobility Device has the meaning set forth and as defined under § 8-44) upon the traveled portion of any public street, multi-use path, or bicycle lane.
    - (2) A bicycle or Micromobility Devices must be parked in designated areas where available.
    - (3) A bicycle or Micromobility Device located on any public property sidewalk within the City's corporate limits shall be parked only in a rack provided to support the bicycle or Micromobility Device, against a building, or in such other manner as not to impede pedestrian traffic thereon and other vehicles movement or obstruct sidewalks, multiuse paths, or access to buildings.
    - (4) A bicycle or Micromobility Device should be parked upright and not left lying on the ground."
- <u>Section 8.</u> Education and Awareness. The City of Carmel will conduct a public awareness campaign to educate residents, visitors, and businesses about the regulations governing micromobility devices. Information about this ordinance and related safety resources will be made available on the City's website and at other public locations.
- <u>Section 9.</u> If any portion of this Ordinance is for any reason declared to be invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance so long as enforcement of same can be given the same effect.

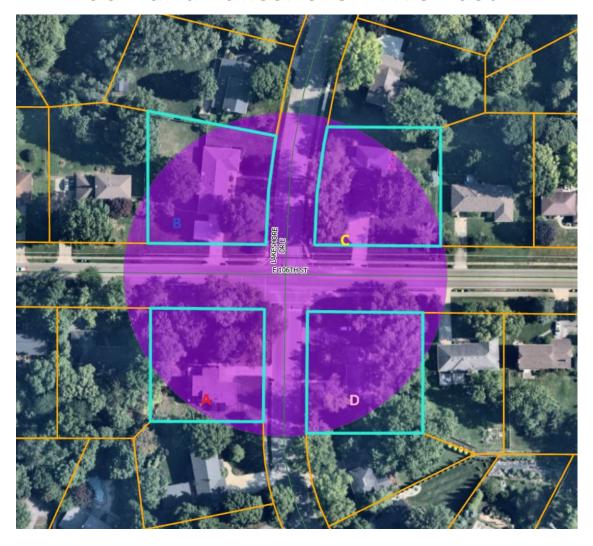
